**EXHIBITS RECEIVED:** Sage Center - Accepted exhibits will be accepted for set up Sunday, August 8, 2010 between 10:00 am - 2:00 pm. Set up must be completed by 2:00 p.m. Exhibits will not be received or set up at any other time. The Sage Center will be closed to the public from Saturday, August 8th through Friday, August 13th. **Display fee must be paid AT TIME OF ENTRY.** Set up will not be allowed if display fee has not been paid.

### RULES AND REGULATIONS:

1. Exhibitors must read and observe the general information at [www.montanafair.com](http://www.montanafair.com) and rules for Hobby Hall and any specific rules for each division and/or class. These rules will be adhered to explicitly.
2. The attractive arrangement of exhibits widely diversified in character governs the success of Hobby Hall. Facilities for a special display are possible if application for space is made at an early date.
3. No suggestive materials will be accepted. No sponsorship statements or signs will be allowed. No selling of any kind is allowed by exhibitors.

4. MontanaFair reserves the right to remove any material from any exhibit that might be objectionable. Said material will be held in a secure place until exhibit is picked up at the close of the fair. Exhibitors will be notified.
5. No live materials.
6. No responsibility is assumed by MontanaFair in the loss, damage or breakage of an exhibit in route to or from the fairgrounds, or while on the fairgrounds. However, all due care and caution will be exercised to prevent such loss or damage.
7. The judges shall have the authority to disqualify or transfer any exhibit to another division or class at their discretion. All judge's decisions are final.
8. Judges shall reserve the right to award second, third, or no premium if in their judgment the entry does not merit a higher award. This rule applies whether or not there are one or more entries in the class.

### **DIVISION 1 - COLLECTIONS**

1. Any collection or display that is of general interest and worthy of recommendation to others and not maintained for financial gain may be entered.
2. Entries may be entered as a competitive exhibit or as a noncompetitive exhibit.
3. Collections which were formerly displayed may reapply if the collection has been significantly changed.
4. Tell in a brief statement (1 to 2 paragraphs) how your collection was started, what your favorite piece is and what makes your collection unique, etc. Entries will not be accepted without this information. Bring your statement, typed in a font no smaller than 24 to the set up. This is considered part of your entry display and your exhibit will not be eligible for prize consideration without this element.
5. Exhibits eligible for show in other departments will be accepted only as noncompetitive exhibits and will not be judged.
6. Character based collections will be placed in the category they originated in (i.e. Beatles enter in music; Scooby-Doo enter in TV)

**DIVISION 3 – CLUB PARTICIPATION**

1. All clubs who wish to be eligible for Club Participation Best of Show and Judge's Choice must enter under club name on entry form and pay exhibitor fee. Selection for Best of Show Award will be chosen by the MontanaFair Advisory Board members based on booth appearance, presentation and interaction with fair patrons. Selection of Judge's Choice will be made by the MontanaFair Hobby Hall judges.
2. Entries must have an appropriate display of the hobby including examples of items, process of how items are made, information about the club, pictures or items showing what the club is about.
3. All Club Participation entries will have demonstration times scheduled by the Superintendent for demonstrators scheduled to talk about or demonstrate hobby. Demonstrations may have audience participation or interaction.
4. Only clubs who provide a display attendant during Hobby Hall exhibit hours will be eligible for cash awards.
